

Use of Child Imagery HG 27

This Policy

This Policy is intended to provide information to pupils and their parents, carers or guardians (referred to in this policy as "parents") about how images of pupils are normally used by West Hill Park School ("the School"). It also covers the School's approach to the use of cameras and filming equipment at school events and on school premises by parents and pupils themselves, and the media.

It applies in addition to the School's terms and conditions, and any other information the School may provide about a particular use of pupil images, including e.g. signage about the use of CCTV; and more general information about use of pupils' personal data, (e.g. the School's Data Protection Policy for Pupils and Parents).

Parents who accept a place for their child at the School are invited to agree to the School using images of him/her as set out in this policy, by signing the Consent Form sent out with the School's Terms and Conditions. We hope parents will feel able to support the School in using pupil images to celebrate the achievements of pupils, promote the work of the School, and for important administrative purposes such as identification and security.

The School will always respect the wishes of parents/carers (and indeed pupils themselves) where reasonably possible, and in accordance with this policy.

Use of Pupil Images in School Publications

The attached consent form will, if signed by the parent or where appropriate the pupil, allow the school to;

- use images of its pupils to keep the school community updated on the activities of the School, and for marketing and promotional purposes, including;
 - o on internal displays (including clips of moving images) on digital and conventional notice boards within the school premises;
 - o in communications with the school community (parents, pupils, staff, Governors and alumni) including by email, school magazine and by post;





- o on the School's website and, where appropriate, via the School's social media channels, e.g. Twitter and Facebook. Such images would not normally be accompanied by the pupil's full name; and
- o in the School's prospectus, and in online, press and other external advertisements for the School. Such external advertising would not normally include pupils' names.

The source of these images is predominantly the School's marketing department and other appropriate staff in relation to school events, sports or trips. The School will only use images of pupils in suitable dress.

Use of Pupil Images for Identification and Security

- 1. All pupils are photographed in September each year, and annually thereafter, for the purposes of internal identification. These photographs identify the pupil by name, year group, house and form/tutor group.
- 2. CCTV is in use on school premises, and will sometimes capture images of pupils. Images captured on the School's CCTV system are used in accordance with the School's Data Protection Policy for Pupils and Parents/Carers, and any other information or policies concerning CCTV which may be published by the school from time to time.

Use of Pupil Images in the Media

For events or school activities in which pupils are participating where the media is expected to attend, we will make every effort to ensure that any pupil whose parent or carer has refused permission for images of that pupil to be made in these circumstances are not photographed or filmed by the media.

The media normally asks for the names of the relevant pupils to go alongside the images, and these will only be provided if consent has been given.

Security of Pupil Images

Professional photographers and the media are accompanied at all times by a member of staff when on school premises. The School uses only reputable professional photographers and makes every effort to ensure that any images of pupils are held by them securely, responsibly and in accordance with the School's instructions.







The School takes appropriate technical and organisational security measures to ensure that images of pupils held by the School are kept securely, and protected from loss or misuse, and in particular will take reasonable steps to ensure that members of staff only have access to images of pupils held by the School where it is necessary for them to do so.

All staff are given guidance on the School's Policy on Taking, Storing and Using Images of Pupils, and on the importance of ensuring that images of pupils are made and used responsibly, only for school purposes, and in accordance with the School's policies and the law.

Use of Cameras and Filming Equipment (including mobile phones) by Parents

Parents are welcome to take photographs of (and where appropriate, film) their own children taking part in school events, subject to the following guidelines, which the School expects all parents to follow:

When an event is held indoors, such as a play or a concert, parents should be mindful of the need to use their cameras and filming devices with consideration and courtesy for cast members or performers on stage and the comfort of others.

In particular, flash photography can disturb others in the audience, or even cause distress for those with medical conditions; the School therefore asks that it is not used at indoor events.

Parents are asked not to take photographs of other pupils without the prior agreement of that pupil's parents, except incidentally as part of a group shot.

Parents are reminded that such images are for personal use only. Images which may identify other pupils should not be made accessible to others via the internet (for example on Facebook), or published in any other way.

Parents are reminded that copyright issues may prevent the School from permitting the filming or recording of some plays and concerts. The School will always print a reminder in the programme of events where issues of copyright apply.

Parents may not film or take photographs in changing rooms, the swimming pool or backstage during school productions, nor in any other circumstances in which photography or filming may embarrass or upset pupils.

The School reserves the right to refuse or withdraw permission to film or take photographs (at a specific event or more generally), from any parent who does not follow these guidelines, or is otherwise reasonably felt to be making inappropriate







images.

The School sometimes records plays and concerts professionally (or engages a professional photographer or film company to do so), in which case copies of the DVDs and CDs may be made available to parents for purchase. Parents of pupils taking part in such plays and concerts will be consulted if it is intended to make such recordings available more widely.

Use of Cameras and Filming Equipment (including mobile phones) by Staff (Teaching & Support)

Photographs or video will only be taken by a designated staff member/s. Where photographs are taken by staff to give evidence of pupils' progress or to record a trip or sporting event, photographs may be taken on school equipment or on a staff member's personal device.

If taken on a personal device, images must be deleted as soon as possible, after either transferring to a school system or posting to an authorised school service. Photographs or video cannot be used or passed on outside the School.

Neither staff nor children may use their own mobile phones to take photographs or video within our EYFS setting; nursery and up to Reception.

When taking photographs in School, staff must;

- be clear about the purpose of the activity and what will happen to the photographs when the lesson/activity is concluded;
- ensure that photographs are taken for valid educational purposes and, if in doubt, consult with their line manager;
- ensure that all images are available for scrutiny in order to screen for acceptability;
- be able to justify images of children in their possession;
- avoid making images in one to one situations;
- not have images of pupils stored on personal cameras, devices or home computers;
- not make images of pupils available on the internet, other than through the official School network/website with permission from parents and senior leaders.

Use of Cameras and Filming Equipment by Pupils

All pupils are encouraged to look after each other, and to report any concerns about the







misuse of technology, or any worrying issues to a member of staff.

The use of cameras or filming equipment (including on mobile phones) is not allowed in dormitories, toilets, washing or changing areas, nor should photography or filming equipment be used by pupils in a manner that may offend or cause upset.

Pupils are told they should not film or take photographs of other members of the school community (pupils and staff), other than where there is a justifiable, educational reason. Using photographic material of any kind to bully, harass or intimidate others will not be tolerated and will constitute a serious breach of discipline.

Where there is an allegation about a pupil taking inappropriate images, a senior member of the pastoral team may request access to images stored on mobile electronic devices and/or cameras and ask the pupil to delete the images in question. Photographs of any member of the School community are not permitted to be displayed publically around the school campus unless in accordance with this Policy.

The misuse of cameras or filming equipment in a way that breaches this Policy, or any of the School's other policies including but not limited to the Anti-Bullying Policy, Promoting Good Behaviour Policies, Data Protection Policy for Pupils and Parents, and Internet and Network Acceptable Use Policy is always taken seriously, and may be the subject of disciplinary procedures.
